The Texas Forestry Association Master Policy has an effective date of August 1, 2009 to August 1, 2010. The effective date of your policy will be August 1, 2009, or the day after the postmark date on the envelope containing your application and premium payment, if received after that date, until August 1, 2009

**Premiums are not pro-rated if you apply after (the date of the first bound policy).**  
**Premiums are 100% earned and there is no refund of premium if the policy is cancelled mid-term.**
